You will now be aware that the Walking for Health charity, under the name of Action for Life, was dissolved on 13 April 2015. However, the scheme continues under a new name and management.

We are pleased that **East Surrey Walking for Health** is now managed by **YMCA East Surrey** – a vibrant local charity that supports individuals and communities. Given their well-established health and wellbeing programmes, together with their experience of sport and physical activities, we feel that the YMCA's management of the walking scheme makes for a very good fit.

East Surrey Walking for Health is one of six schemes in Surrey and is the largest in terms of number of walks, volunteers and walkers. We currently operate 22 individual walks across Reigate & Banstead and the Tandridge district. In January 2015, our scheme was accredited by our national body: Walking for Health, and we are very pleased to have 52 dedicated trained volunteer walk leaders

We would like to take this opportunity to thank you for your support so far. Your membership and voluntary donation are still as valuable and necessary as ever. In the past year, this has helped towards the management of walks across the scheme along with the publishing of up to date walks programmes; Stepping Out newsletter and other literature; the cost of postage and stationery, and room hire. Together, we are making a real and lasting difference to the health of people in East Surrey.

If you wish to continue supporting our healthy walks, we usually suggest a **voluntary annual** donation of £10. However, any donation is welcomed. Details are outlined below.
